## Championing Equality, Defending Freedom: Civil Rights & Immigration

### 280 Civil Rights Consultations & Cases. Here's a few examples:

- **Securing Workplace Rights:** Ensured workplace rights & religious accommodations for **45** employees
- **Combating Discrimination and Hate:** Defended **52** individuals against discrimination and hate crimes
- **Protecting Children:** Intervened in **6** bullying incidents to safeguard our children.
- **Upholding Religious Freedoms:** Advocated for the religious rights of **24** Muslim inmates
- **Shielding from Unjust Targeting:** Protected **10** individuals from government and law enforcement harassment.

### 61 Immigration & Asylum Consultations & Cases. Here's a few examples:

- Secured **13** US Citizenships, **21** Permanent Residencies, & **more than three dozen** Employment Authorization
- Filed **36** Asylum applications
- Advocated for **more than a dozen** families through immigration petitions
- Handled **22** immigration-related cases, including **1** Temporary Protected Status

## Legislative Engagement.

Actively participated in the **2024 Florida Legislative Sessions**, engaging legislators from both parties.



## Community Advocacy

Conducted **candidate interviews** to highlight Muslim and Arab community concerns.



## Amending Anti-Semitism Bills.

Successfully influenced amendments to **HB 187** and **SB 148 to uncriminalize criticism of Israel**



## Fostering Unity

## Combatting Islamophobia.

Strategically opposed HR 1209 by Rep. Randy Fine, defending CAIR against false allegations.
